SITE SURVEY

An official site visit for this solicitation is scheduled to be on July 27, 2021. The site visit will take place at ILEA Bangkok at 10.30 AM local time (UTC+7). Attendees must be at ILEA Bangkok main entrance (Gate 2) by 09.45 AM local time (UTC+7) to complete the required sign-in.

A maximum of three (3) representatives per company will be allowed at the site visit. Access to the location requires prior authorization from ILEA Bangkok. Only individuals that have been granted access by ILEA Bangkok will be allowed at the site visit. Access requests must be submitted at minimum three days in advance and no later than 03.00 PM local time (UTC+7) that day to SmitB@ileabangkok.com and must include the following information:

2. Full name of all attendees in English (not to exceed three (3) attendees per company)
3. Copy of government-issued identification (ID) for each attendee

Attendees will be required to sign-in utilizing the government-issued identification used to request access. Additionally, the attendee must provide acceptable proof of company affiliation. Prospective Offerors will only be allowed to inspect the location of work during the scheduled site visit. Prospective Offerors that are unable to attend the scheduled site visit will not be provided another opportunity to inspect the site.

The core equipment that will be implemented for this project must be TAA Compliant, that meaning it is manufactured or substantially transformed in a TAA compliant country – more information here.

NETWORK TOPOLOGY DESIGN

The Contractor must propose Wi-Fi 6 solution and equipment based on the provided network topology design below. The Data Center locates at the Administrative Building second floor shall host core controller equipment and main distribution point to the two communication racks locate at the Dormitory Building first and fifth floor. The three communication racks are interlinked with multimode fiber optic. The Contractor may use these rack space to mount access point equipment such as switch, patch panel, and cabling management, and at maximum ILEA will be providing two VM servers for this project. Else the Contractor must consider any other equipment, software, and/or license necessary to complete the project.

The connection between the datacenter at the administrative building to the main cabinet rack on the first floor at the dormitory building must be fiber optic multimode OM3.

The connection between the main cabinet rack on the first floor to floor communication rack locates on the third and fifth floor at the dormitory building must be fiber optic multimode OM4.

Question 1: According to information on network topology design.

Is it OM2 or OM3 multimode fiber that ILEA use to connect the administrative building and the dormitory building?

The connection between the datacenter at the administrative building to the main cabinet rack on the first floor at the dormitory building is fiber optic multimode OM3.

The connection between the main cabinet rack on the first floor to floor communication rack locates on the third and fifth floor at the dormitory building is fiber optic multimode OM4.

Question 2: According to list of equipment item 4 (Network Management System). Is it really required to support 300 different devices? Because there are around 100 devices in a wireless system.

Question 3: According to list of equipment item 9 (Cabling and Accessories). On the day of the site survey entry. K.Smit mentioned that EMT pipes are acceptable, but the document states that only IMC pipes can be used, therefore please clarify that EMT pipes are acceptable.
