## **STATEMENT OF WORK**

### **Background**

American Hub (AH) which is controlled and managed by Media and Cultural Affairs Office, is the center that provides free resources to support all kind of large public programs to specific small meeting. AH aims to provide all-in-one place service to support all requirements which can meet at least one of the Mission Goals. Our target audiences range from students, academic institutions, individual to organizations. The program performed at the AH includes regular Zoom meeting; virtual/online program with Zoom, WebEx, Google Meet, Skype, etc.; virtual press interview; and other interactive virtual programs as requested.

### **Objective**

Prior to the pandemic situation, AH will usually host at least 15 programs per month which most of them are people-to-people activities. After pandemic has started, all kind of physical programs are shifted to virtual programs which we will require the service to help upgrading the current control system. The current HDMI Matrix system which supports all kinds of meeting/conference package at the hub has been installed for six years ago and part of the system are out of date and not working properly. The new system that will be replaced should be able to support high-definition content (both visual and audio) according to the on-going technology which must be able to upgrade on monthly basis.

The contractor shall provide high quality products, professional service and installation, customized service in delivery within the limited time frame. Quality control for each item should be focused to ensure the overall performance of the American Hub.

The new HDMI Matrix system must be able to support all equipment at the hub. There are 3 main areas to be included and serviced:

- Auditorium (max 100 people)
- Conference room (max 10 people)
- Reception area

The main control system will be located next to the Auditorium, controlled and managed by Embassy Audio Visual Technician.

The contractor should be able to provide and install these items at the hub:

1. HDMI Matrix Switcher 4K, total 1 unit
2. HDMI 1-Gang PoE Wall-Plate Transmitter with RS-232 & IR, total 8 units
3. HDMI Bidirectional PoE Receiver with RS-232 & IR over HDBaseT, total 16 units

5. Accessories set for all kind of installation (cables, joints, etc.), to support all items above
6. Perform the professional installation according to Embassy AV Technician guidance
7. Perform the testing of the overall system after installation is completed
8. Perform the full-course training of all installed equipment to Embassy AV technician
9. Provide one-year onsite service after delivery has been completed.

### **Terms and Conditions**

Security: An awarded Contractor must submit a name list of workers including their ID number and vehicle license plate to COR two days prior starting the job.

Testing: The Contractor shall perform pre-qualification testing during installation to ensure quality control and that the system will pass qualification testing.

Warranty: A minimum of one (1) year total solution warranty with onsite service and advance spare part. The warranty cannot be less than what is offered to the general public.

On-Site Service Agreement: The Contractor must be able to respond to a service request by the next day. The Contractor must provide product and system familiarization session(s) to system administrators.

Product on-site training is required. The Contractor shall at least one full training for new users in Thai and English. This shall include theoretical and practical sections of how to operate the equipment.

Administration: The Contractor must prepare and submit for Media and Cultural Affairs Office approval a practicable schedule showing the order in which the Contractor proposes to perform the work and the dates on which the Contractor contemplates starting and completing the several salient features of the work (including but not limited to acquiring materials, installation, testing, and product familiarization).

Installation: The Contractor shall provide all equipment and manpower required for complete delivery and installation of all items necessary for this installation. The Contractor shall furnish a written work plan for the Project Owner's review outlining planned work, identifying known safety risks, and all method to eliminate or mitigate unexpected problem, must be submitted along with the quotation within the deadline. ALL DAMAGE during any part of the process shall be the

responsibility of the Contractor and any damages shall be replaced/repared by the Contractor at no additional cost to the U.S. Embassy.

Waste Disposal: The Contractor shall haul away from the project and legally dispose of all debris to an offsite location.

Site Clean-up: Site clean-up shall be performed by the Contractor.

Final Clean-up: The Contractor shall be responsible for the full and thorough cleaning of the work areas following project completion. Work areas shall be free of dust, dirt, and debris and suitable for immediate use by the Owner when complete.

Inspection and Acceptance: The COR, or his/her authorized representatives, will inspect from time to time the services being performed under this contract and the supplies furnished to determine whether work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall provide project completion documentations for all hardware and/or software delivered under this project. At a minimum, the closeout documentation must include:

- a) Comprehensive Bill of Material for all hardware and software delivered under the contract. The list shall include: Item Description, Name of Manufacturer, Model Number, Serial Numbers, Delivered Quantity, Unit Price, Extended Price, Warranty Start and Expiration Date, and Subscription Start and Expiration Date
- b) OEM manuals for all hardware and software delivered under this project.
- c) Final Physical and Logical Designs and Diagrams.
- d) Warranty and Technical Support documentation. Documentation shall include an explanation of coverage, the process to obtain warranty or technical support services, and applicable contact information.
- e) User Manual Guide Book in Thai and English language.

The Contractor must provide a physical diagram in a digital copy form of the design for the entire solution including the location and all components being installed.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

### **Specification Requirements:**

A specification sheet of all items is required for this request for technical evaluation. It needs to be submitted along with the quotation within the deadline.

**Insurance:**

**Local VAT Exemption:**

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

*Highest-level owner* means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

*Immediate owner* means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

*Inverted domestic corporation*, means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

*Manufactured end product* means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern*—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service connected, as defined in 38 U.S.C. 101(16).

*Small business concern*—

The term "successor" does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

  - (1) On the date specified for receipt of offers, if award is based on initial offers; otherwise
  - (2) On the date specified for receipt of proposal revisions.
