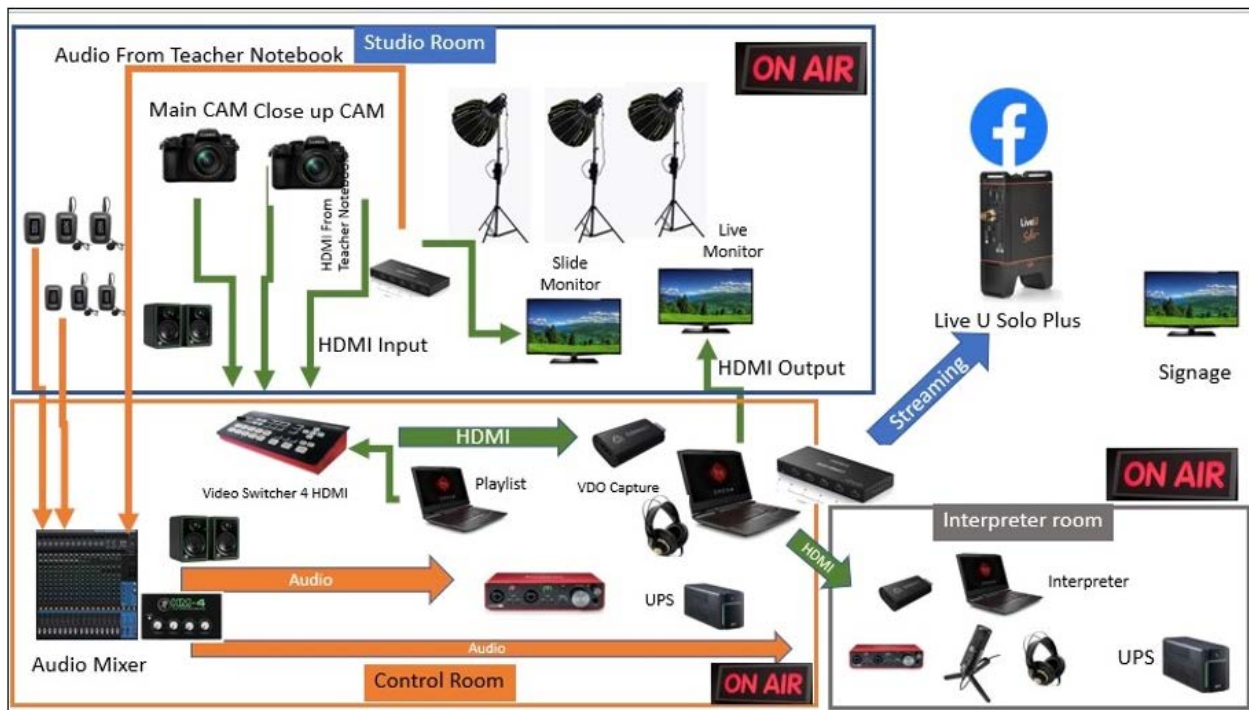

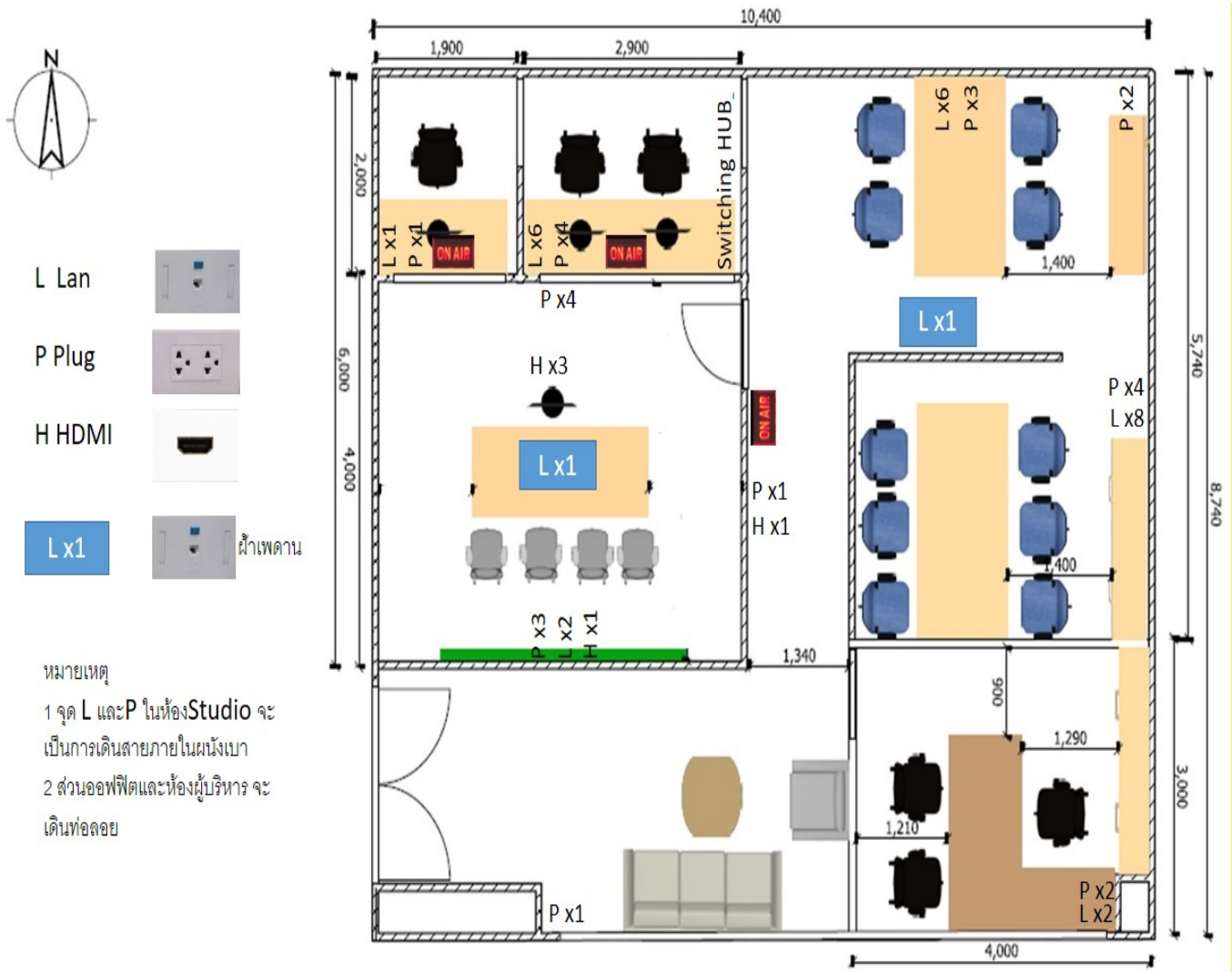
ATTACHMENT #2 – Floor Plan (1)
