Quotations are due by December 7, 2022, at 16.00 hrs. (local time). No quotations will be accepted after this time. Proposals must be in English and incomplete proposals will not be accepted.

Your quotation must be submitted electronically to BKKGSOProcBid@state.gov. It is important to make sure the submission is made in specific size and format; in MS-Word 2007/2010 or MS-Excel 2007/2010 or Adobe Acrobat (pdf) file format. The file size must not exceed 30MB. If the file size should exceed the 30MB, the submission must be made in separate files and attached to separate emails with less than 30MB each.

In order for a quotation to be considered, you must also complete and submit the following:

2. Section 1, Pricing
3. Section 5 Representations and Certifications
4. Additional information as required in Section 3
5. Proof of SAM Registration

Offerors shall be registered in the SAM (System for Award Management) database at <https://www.sam.gov> prior to submittal of their offer/proposal as prescribed under FAR 4.1102 for offers over \$30,000. Failure to be registered at time of proposal submission may deem the offeror's proposal to be considered non-responsible and no further consideration will be given.

Therefore, offerors are highly encouraged to register immediately if they are interested in submitting a response to this requirement.

I. SCOPE OF SERVICES

Contractor shall provide hotel rooms and conference rooms with meeting package at the same venue in Bangkok, Thailand. Period of Performance is February 12, 2023 to February 18, 2023. Contract type will be purchase order.

Lodging rooms shall include private bath, heating and air conditioning, and telephone, in the hotel located in Bangkok, Thailand. The Government shall be liable for the price of each room ordered but not used, unless the Contracting Officer gave the Contractor an oral or written cancellation no less than one day before the anticipated effective date.

II. PRICES

B. VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government. VAT Exemption document will be processed through Ministry of Foreign Affairs for the order which has the total price excludes VAT at or more than 5,000 THB for local VAT registered contractor under Section 82/3 of Thai Revenue Code only. The contractor will receive the document within 150 days after submitting the invoice.

Hotel Rooms Requirement

- Check in: Participants will check-in on February 12, 2023, two meeting coordinators will check-in earlier on either February 10, 2023 or February 11, 2023.
- Check out: Participants will check-out on February 18, 2023, two meeting coordinators may check-out on February 19, 2023.
- Estimated hotel room reservation will be from 45 to 55 rooms.
- Guaranteed early check in is required. If guaranteed early check in is not available, the contractor must provide a storage room in which participants/presenters can leave their luggage under lock/key controlled by the meeting coordinators (not by the contractor).
- Two of the rooms must be club-level rooms with the same rate as the normal hotel rooms and have full access to club-level facilities to include a private individual meeting room for break outs. If the contractor doesn't have club-level facilities, the contractor must provide 1 private individual meeting room for 3 days instead.
- Full Breakfast must be included. Gluten free, peanut free, fish free and vegetarian meal must be available for selection. Numbers of vegetarians, gluten, peanut and fish free participants will be provided later.

Conference Room Requirement

- Meeting Space
 - Sufficient to accommodate 50 participants. Estimated participants will be from 45 to 55 persons.
 - The conference room must be opened daily from 08:00 – 18:00 hrs. from February 14, 2023, through February 18, 2023.
 - The conference room must be opened for set-up by course coordinator on February 13, 2023, from 12:00 to 18:00 hrs.
 - The contractor must provide eight round tables with chairs for 6 participants.
 - The contractor must provide two rectangular tables at the front of the room with 4 extra chairs.
 - The contractor must provide two rectangular tables at the rear of the room with 4 extra chairs
 - Natural lighting in the conference room is required.
- Audio/Visual
 - The contractor must provide eight flip charts on easels with markers and full pads of paper.
 - The contractor must provide one projector and one screen.
 - The contractor must provide podium with portable microphone.

- The contractor must provide laptop including remote and other accessories that are required for power point presentation.
- Wi-Fi in the conference room and lunch area are required.
- Business Center
 - The contractor must provide access to the Business Center with computer, printer and internet.
 - Minimum 100 pages of black and white photocopying is required.
- Refreshments
 - All day water set for all seats are required.
 - AM coffee break with pastries and juices for all participants are required.
 - PM coffee break with soft drinks and snacks varied each day for all participants are required.
 - Separate coffee break outside of, but adjacent to, meeting space is required.
- Lunch
 - The contractor must provide in-hotel restaurant with designated seating area for the entire group.
 - The contractor must provide a small dining area or reserved table for 12 participants on February 13, 2023 and February 14, 2023.
 - Lunch Buffet style is required. Gluten free, peanut free, fish free and vegetarian meal must be available for selection. Numbers of vegetarians, gluten, peanut and fish free participants will be provided later.

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials .

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture .

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor .

Reasonable inquiry has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment .

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment , as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. (d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations.
