**1) OVERVIEW AND PERIOD OF PERFORMANCE**

The Contractor shall furnish and deliver limited use welcome kits to the U.S. Embassy Bangkok in accordance with the specifications and terms and conditions set forth herein. The prices listed below shall include all labor, materials, overhead, profit, and transportation necessary to deliver the required items to the U.S. Embassy in Bangkok.

The Government will pay the Contractor for indefinite delivery/indefinite quantity (IDIQ) per delivery order that has been satisfactorily performed and accepted. Payment will be at a fixed price.

The Government will pay the Contractor for each delivery order completed under this contract. Delivery orders that are large in scope may be identified for incremental payments based upon percentages of work satisfactorily completed.

***Performance period: One year***

Because the USG translation services are based on indefinite delivery/indefinite quantity the minimum and maximum amounts are defined below:









**Minimum:** The Government shall place orders totaling a *minimum of 9,000 THB per year*. This reflects the contract minimum for the base year and each option period.














**Maximum:** The amount of all orders shall *not exceed 3,750,000 THB per year*.

### **STATEMENT OF WORK**

#### **Objective:**

U.S. Embassy Bangkok, GSO Warehouse seeks to obtain basic limited use welcome kits, which allow employees and families to move directly into their assigned quarters while they await the arrival of their household effects (HHE) shipments, and permit departing employees and their families to remain in their assigned housing after their HHE has been packed and shipped. Welcome kits typically include items needed upon arrival (e.g., basic kitchen set-up, linens, etc.) and should be the minimum needed until the HHE shipment arrives. The quantity and quality of welcome kit items should be kept to a minimum to keep costs low as possible as the welcome kit is not intended to be reassigned to another family.

#### **Scope of work:**

- 1) The contractor must provide items indicated in the enclosed herewith, and pack securely and arrange items into a single cardboard box.
- 2) The contractor will provide welcome kits built for families of 2 persons, 4 persons, and 6 persons in accordance with the items described in the attached list. Boxes shall be clearly labeled (either 2, 4, or 6-person kits) and a packing list shall be provided in a plastic pouch securely taped to the outside or placed inside the box.

#### **Specific Requirements:**

- 1) All goods/items shall be brand-new and in excellent condition and delivered in a single cardboard box.



- 2) All fabric and pillow items must be wrapped or packed tightly in transparent plastic bags to avoid dusting and facilitate packing and storage. Fabric and pillow items should be wrapped tightly in plastic or vacuum packed for maximum compression to save space.
- 3) Items must be arranged neatly and securely in cardboard boxes, having padded materials inside to prevent any damage during the move.
- 4) All goods/items (all types, all pieces) provided by the contractor in every kit must meet the same standard mentioned above.
- 5) A replacement of a discontinued item must be of an equivalent specification, quality and price. Contractor must notify the U.S. Embassy at least 30 days in advance and be approved prior to the kit being assembled.
- 6) The U.S. Embassy reserves the right to purchase individual sample kits from prospective vendors, prior to entering into a contract.

**Price:**

Price per kit shall be determined by the cost of the items provided. This includes the costs of procurement, all kit items, packing and arranging items into a single cardboard box, and storing until delivery. The complete welcome kit will be invoiced as a unit, by either 2, 4, or 6 person units.

The actual invoice must be submitted to the U.S. Embassy to process an application for VAT exemption certificate.

Because this contract is based on indefinite delivery/indefinite quantity, the embassy shall place orders totaling a minimum of THB 9,000, the amount of all orders shall not exceed THB 3,750,000.

All pricing shall reflect Thai Baht. PARTIAL QUOTES ARE NOT ACCEPTABLE.

**Term of payment**

The contractor shall provide a net 30-day payment terms. The U.S. Embassy financial section will transfer the payment for the welcome kits to the contractor within 30 days after receiving the invoice.

**Local VAT Exemption:**

VAT Exemption document will be processed through Ministry of Foreign Affairs for the order which has the total price excludes VAT at or more than 5,000 THB for local VAT registered contractor under Section 82/3 of Thai Revenue Code only. The contractor will receive the document within 150 days after delivery.

**Period of Performance:**

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months.

**Delivery schedules:**

The U.S. Embassy Bangkok will require approximately 170 welcome kits throughout the year, primarily in the spring and summer transfer season. The Embassy will provide the vendor 30 days advance notice to build the welcome kits to make ready for delivery. The vendor shall allow up to 21 days for U.S. Embassy pick up and allow partial pickups.

Remark: These delivery schedules are subject to change.

**Shipping Instruction:**

The U.S. Embassy Bangkok will pick-up the kits from the vendor location in the greater Bangkok area when the welcome kits are assembled.

**Contractor's responsibilities:**

- 1) In the event that any defect (e.g. damage, stain, hole, broken) or missing items inside the kit are discovered, the U.S. Embassy will work with the vendor to resolve any issues.
- 2) Contractor shall replace broken items or provide missing items within 72 hours of notification. Items shall be delivered to the Rajdamri U.S. Government Warehouse in Bangkok.

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the offeror has represented that it “does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument” in paragraph (c)(1) in the provision at 52.204–26, Covered Telecommunications Equipment or Services—Representation, or in paragraph (v)(2)(i) of the provision at 52.212–3, Offeror Representations and Certifications—Commercial Items. The Offeror shall not complete the representation in paragraph (d)(2) of this provision if the Offeror has represented that it “does not use covered telecommunications equipment or services, or any equipment, system, or service that uses covered telecommunications equipment or services” in paragraph (c)(2) of the provision at 52.204–26, or in paragraph (v)(2)(ii) of the provision at 52.212–3.

(a) *Definitions.* As used in this provision—

L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. (A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the Product Service Code (PSC) of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(2) Disclosure for the representation in paragraph (d)(2) of this provision. If the Offeror has responded “does” in the representation in paragraph (d)(2) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment—

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known);

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

(ii) For covered services—

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

*Highest-level owner* means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

*Immediate owner* means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

(9) PSC 9620, Minerals, Natural and Synthetic; and

(10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern—*
