STATEMENT OF WORK

Scope of work:

The Bureau of International Narcotics and Law Enforcement Affairs of the U.S. Department of State (INL) provides cooperative assistance to the Thai Office of Attorney General toward a joint goal of strengthening criminal justice and capacity building efforts under the legal framework of the Letter of Agreement On Narcotics Control and Law Enforcement between the Government of the United States of America and the Government of the Kingdom of Thailand, dated September 20, 2004, as amended (hereinafter “LOA” or “2004 LOA”).

Pursuant to the request of the Office of the Attorney General (OAG), this project is intended to provide the OAG with a fully equipped and operational Portable Training Equipment, designed to enable the OAG to conduct and broadcast live trainings in variety different locations.

INL Bangkok is looking to procure Portable Training Equipment. The product should be the best possible quality level of product and service and be in keeping with the most efficient process in terms of quality versus cost.

It is expected and is an integral part of the vendor’s performance that:

- The vendor will supply the below listed materials and equipment on site.

Testing: The Contractor shall perform pre-qualification testing during installation to ensure quality control and that the system will pass qualification testing.

Warranty: A minimum of one (1) year total solution warranty with onsite service and advance spare part. The warranty cannot be less than what is offered to the general public.

On-Site Service Agreement: The Contractor must be able to respond to a service request by the next day. The Contractor must provide product and system familiarization session(s) to OAG system administrators.

Product on-site training is required. The Contractor shall at least one full training for new users in Thai/English. This shall include theoretical and practical sections of how to operate the equipment.

L. 115-232) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services

as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to—
